## Adoption Credit Triggers Five-Figure Tax Refunds for Parents

The cost of raising a child from birth to age 18 is \$286,000 -- without the cost of college.(1) Adoptive parents can expect to spend another \$30,000(2) for attorney fees, placement agencies and travel expenses. Adoptive parents also can "carry-forward" credits for adoptions dating back as far as 2005 for potential refunds on their 2010 tax returns.
